

The Society for Biotechnology, Japan (SBJ), as an academic society situated in Asia, is actively engaged in collaboration with societies of other Asian countries in the field of biotechnology.

Academic Agreements with Societies in Asia

1. **The Korean Society for Biotechnology and Bioengineering (KSBB)**

Since 1998, SBJ has agreement with KSBB for the promotion of collaboration. Every year each society invites five speakers from the counterpart society to its own annual meeting, or symposium through which each society exchanges the advanced scientific knowledge and acknowledges the activity range of each society. SBJ selects three delegates from among the awardees of the Society Award, the Saito Award, the Eda Award, the Terui Award, and the Technical Award.

KSBB members can subscribe to the SBJ journals (Journal of Bioscience and Bioengineering and Seibutsu-kogaku Kaishi) at a reduced rate. Online-only option is also available for KSBB members to access the full text of the Journal of Bioscience and Bioengineering (JBB) back to Vol. 64 (1986) through ScienceDirect.

2. **Thai Society for Biotechnology (TSB)**

TSB members can get a user account to access the full text of JBB back to Vol. 64 (1986) through ScienceDirect at a reduced rate.

3. **Biotechnology and Biochemical Engineering Society of Taiwan (BEST)**

SBJ and BEST signed an MOU on June 24, 2017 to promote the interaction and active scientific collaboration between the two Societies and their members.
